Shared resources with local Cemetery Districts Informed the Board that Jonathan from Elk Grove Cemetery District is working with attorney, Mark Velasquez, to set up a program where Cemeteries can share resources in times of emergency, i.e. if a cemeteries grounds crew is all out sick we could send some of our employees to assist with opening graves so as not to disrupt services. As more information comes it will be brought to the Board.

- 1. New Water Tank Project in Newcastle Undeveloped area Jimmy informed the Board that he is still awaiting the drawings from the Engineer.
