## STANDARD & INFANT PLOT FEE SCHEDULE

EFFECTIVE: March 1, 2019

*The District accepts payment by cash, check or charge (3% convenience fee for debit/credit)*

***In District Sales*** - (Per California Health & Safety Code) - Restricted to those person(s) who own property and/ or reside with in District boundaries. Proof of property ownership or residency is required to purchase plots. Plots may be purchased for immediate family members only.

***Out of District Sales*** - (Per California Health & Safety Code) - Sales to non-residents is limited to those persons who have members of their immediate family who own plots, reside in District, or are buried in the District's cemeteries. Proof of family relationship will be required. Qualifying Out of District customers must pay Out of District fees.

### BURIAL PLOTS (GRAVES)

Full and premium size burial plots may accommodate one casket and/or up to six cremated remains per plot. Additional fees will apply per each additional interment right. All burrial plots are for single depth casket burrial only.
